- Research Grant Proposal Submission Template

Submissions must reflect **all** the following points:

1. Test all or some of the best practice recommendations of the paper Ng DHL, et al. *Nutrients* 2023;15(21):4492.
2. Reflect the multi-disciplinary collaborative effort to support after discharge nutrition care that is sustainable within the hospital system.
3. Include an intervention / study period of no more than 6-months and all data analysis should be completed within 9-months of the award of the grant.

1. Entrants must submit Research Proposals using this template.
2. Research Proposals have a 2000-word limit (words above this limit will not be considered)
